





# Introduction of the Faculty



Mr. Kening Zhang obtained his S.J.D. from Peking University. From 1987 to 1993 he worked for the Department of Treaty and Law at the Chinese Foreign Ministry. After that, he served as Counselor and Legal Advisor to the Chinese Mission to the United Nations in New York before joining the Secretariat of the International Seabed Authority in 1997. He has worked at the International Seabed Authority for 16 years until his retirement in 2013 as Principal Legal Officer and Interim Director-General of the Enterprise. He is currently serving as Professor of Law with the South China Sea Institute and Director of the Centre for Oceans Policy and Law, Xiamen University.



Ms. Rachael Lorna Johnstone is Professor of Law at the University of Akureyri, Iceland and Professor of Law, Arctic Oil and Gas Studies, at the University of Greenland. She holds a doctorate in juridical science from the University of Toronto (2004). She specializes in Polar law: the governance of the Arctic and the Antarctic under international and domestic law. She is also a member of the Arctic Law Thematic Network of the University of the Arctic and the International Law Association Study Group on Due Diligence.



Ms. Ping Guo is Professor of Law School, and Director of Institute of International Maritime Law (IIML), Dalian Maritime University. She holds a LL.M (1998) in International Economic Law and a LL.D (2006) in nternational Law from Dalian Maritime University. She specializes in maritime law and environment & resources protection law. She is also an Arbitrator of China Maritime Arbitration Commission and Dalian Arbitration Commission, Member of Council of China Maritime Law Association, and Vice General-secretary of Liaoning Province Maritime Law Association.



Mr. Kuen-Chen Fu is Professor and Dean of Xiamen University's South China Sea Institute. He is among the scholars recruited through China's "Thousand Talents" program. Prof. Fu received his S.J.D. from the University of Virginia in 1983 and is a leading scholar of international law of the sea. He previously taught at Taiwan University and other universities in Taiwan and served as a Editor-in-Chief of China Oceans Law Review and the South China Sea Bulletin.

All courses will be conducted in English. Certificate of Attendance will be granted at the closing ceremony of the session. There will be no tests, unless requested by any student. In this case, a Certificate of Grade will be awarded at the end of the session in addition to the Certificate of Attendance.
